**Note:**

1. The applicant should submit the application under the same name as approved under the PMAY-U scheme.
2. The Form should be complete in all aspects. No application shall be considered valid unless it is made in the prescribed format and is accompanied by the requisite ID Proof etc.
3. This Form is free of charge and can be downloaded from the T&CP Department's website.
4. The allotment criteria shall be as per clause no. 2.5 and 6.5 of PMAY guidelines issued by Ministry of Housing and Urban Affairs, 2016 (Link [http://mohua.gov.in/upload/uploadfiles/files/18HFA\\_guidelines\\_March2016-English.pdf](http://mohua.gov.in/upload/uploadfiles/files/18HFA_guidelines_March2016-English.pdf)).
5. The allotment rate of the apartment shall be as per rates prescribed under the policy notified vide no. PF-27/48921 dated 19.08.2013 (*details available at the Department website, ie. tcpharyana.gov.in*).
6. The scrutiny of applications and draw of lots shall be conducted by the committees constituted as under:
  - i. Under the chairmanship of Commissioner in case of Municipal Corporations, with concerned Executive Officer, MC and DTP as members
  - ii. Under the Chairmanship of DC in case of other municipalities with concerned Executive Officer/Secretary of the municipality and DTP as members.
7. Application shall be accompanied by the following booking amount:-
  - i. Rs. 50, 000/- in case of Gurugram, Faridabad, Panchkula and Pinjore
  - ii. Rs. 45,000/- in case of other High and Medium potential towns;
  - iii. Rs. 37,500/- in case of Low potential towns

25% of cost of flat less the amount already deposited with the application shall be demanded from the successful candidate on allotment. Balance 75% of the amount in six equal monthly installments over three year period. No interest shall fall due before the due date of payment. Any default in payment shall invite interest at the rate of 15% per annum on delayed period.
