Subject: Invocation of rejection orders dated 18.11.2014 in respect for renewal of the licence no. 25 of 2009 dated 15.06.2009.

Reference: In continuation of this office memo no. 6468 dated 023.04.2015 and 13661 dated 29.07.2015 above cited subject.

2. While considering your review application dated 05.12.2014, the orders issued vide this office memo dated 18.11.2014 regarding rejection of renewal application were revoked subject to the condition that you shall remove all the deficiencies conveyed in the said rejection order and submit requisite documents within 15 days.

3. Whereas, you had submitted some documents after rectifying some of the shortcomings on 18.02.2015, which was examined and noticed that interest amounting Rs. 4,10,500/- on account of delay in payment of deficit renewal fee has not been deposited, therefore, request was made to deposit the same within seven days vide memo No. 6468 dated 23.04.2015. On non-receipt of the said amount, a final opportunity was given to deposit the same within three days vide memo dated 29.07.2015, but you have not responded to the same even after lapse of a period of about 20 days, which shows that you are not interested to continue with the licence in question. Therefore, the rejection orders issued vide memo dated 18.11.2014 are invoked hereby with immediate effect. Due to invocation of orders dated 18.11.2014, the application for renewal of license stands rejected and as a result thereof, the license is deemed to be cancelled.
