**SUBJECT: TO RESOLVE THE ISSUES PERTAINING TO THE DEMANDS RAISED BY REAL ESTATE SECTOR - RECOVERY OF ORIGINAL EDC.**

*Ref. In continuation of this office memo No.Misc-374/Vol-II/5/32/09-2TCP, dated Chandigarh, the 5.4.2010 and DTCP U.O. No.2144, dated 19.4.2010.*

The matter has been deliberated by the Government and it is felt that relief for deferment of payment of EDC conveyed originally at the time of grant of licence may be given to the colonizers upto 30.5.2010, where licences have been issued on/after 1<sup>st</sup> January, 2005. The building plans/zoning plans/service plans and estimates of such cases, may be approved/released by Director provided the colonizer pays the due interest on originally conveyed EDC and enhanced EDC alongwith all other pending dues. The balance amount of originally conveyed EDC will be paid by the colonizer in six monthly installments within two years alongwith applicable interest for which an undertaking shall be given by them. Failure to keep the commitment will result in not only levy of penal interest but cancellation of licence also as repeated failure to pay the due amount to Government proves financial incapacity of the colonizer.
