

## ORDER

In compliance with the orders of the Hon'ble High Court dated 13.11.2014 in CWP No. 16157 of 2014, a meeting of the objectors were called in the Office of Director General Town and Country Planning today at 11.00 AM after giving intimation to the objectors, who had filed the objections in furtherance to the public notice dated 16.05.2014. The objectors heard on the revised layout plan of residential plotted colony (Licence no. 64 of 2010 dated 21.08.2010) in Sector-60, 61, 62, 63, & 65, Gurgaon Manesar Urban Complex granted to individual land owners and companies C/o Krrish Buildtech Pvt. Ltd. and the following directions are passed:-

- i. The developer shall display the revised layout plan alongwith the sanctioned existing plan in the O/o District Town Planner, Gurgaon by 28.01.2015.
- ii. The developer shall display the list of all the allottees who have been allotted land/plots with respect to licence no. 64 of 2010 alongwith area of the plot, plot numbers and giving the details of the changes made. The developer shall also give the details of all the allottees to whom the land has been sold by co-owners and co-developers including ABW Infrastructure Ltd., Gurgaon and Krisssh Realtech Pvt. Ltd., Gurgaon. This information shall be displayed by 02.02.2015 at the DTP, Gurgaon office and be supplied to DGTCP. It will also be published in the four national newspapers for two days i.e. on 30 & 31 January.
- iii. The developer shall comply with the conditions imposed under the licence especially Rule 24, 26 & 27 within three weeks.
- iv. The Department shall find out the status of SLP pending in the Supreme Court of India, which is listed on 15.02.2015 as well as other civil litigations.
- v. The developer shall also display the name of allottees, whose plot sizes have been changed unilaterally. It is directed that no such changes in the size should be attributed to Revision in LOP by the licensee.
- vi. The developer shall comply with the condition imposed by the Directorate letter dated 08.05.2014.
